Concordia Privacy Statement

Surveys & Interviews Teach-the-Teacher

This Privacy Statement ('Statement') relates to certain surveys, interviews and its content if and to the extent provided or otherwise made available in any way and from time to time by CONCORDIA to participants of the Teach-the-Teacher surveys and/or interviews ('Participant'). CONCORDIA is a project focusing on cybersecurity, which is run by a consortium of project partners and funded by the European Union's Horizon 2020 research and innovation program under grant agreement No. 830927 ('CONCORDIA'). This Statement governs the privacy and related matters when participating in the Teach-the-Teacher surveys and/or interviews of CONCORDIA and how a Participant can exercise its rights regarding its Personal Data, in accordance with the General Data Protection Regulation ('GDPR') and other related laws and regulations.

When participating to the Teach-the-Teacher surveys and/or interviews (performed by partners of the consortium) Participant acknowledges that Participant have read, understood, and agree to be bound by this Statement and to comply with all applicable data protection laws and regulations. If Participant does not agree to this Statement or the compliance obligations, please do not participate in CONCORDIA's surveys and interviews.

For purposes concerning this Statement, the Teach-the-Teacher surveys and/or interviews are performed by certain authorized partners of the consortium of CONCORDIA (being: EIT Digital, University Bundeswehr Munich/ Research Institute CODE, Cyprus University of Technology, University of Lorraine, University of Maribor, University of Insubria, Jacobs University Bremen, and University of Patras, as detailed on https://www.concordia-h2020.eu/consortium/), and to the extent applicable exclusively for the benefit of CONCORDIA.

When participating to the Teach-the-Teacher surveys, CONCORDIA does not collect and process any Personal Data of the Participants without their consent. For the avoidance of doubt, filling in the survey will be anonym and Personal Data will be requested and provided at the choice of the Participant when completing the survey. CONCORDIA solely collects and process Personal Data of Participants when a Participant provides its consent in order to answer additional questions through a further exploring interview with regard to the survey. In such case CONCORDIA need to collect the following Personal Data: name, surname, organization, and e-mail address in order to contact the Participant and to perform such interview.

When a Participant participate in the Teach-the-Teacher surveys and/or interviews, CONCORDIA may retain those communications, responses, output and results in order to process the surveys and interviews. Information and responses that Participants provide in the Teach-the-Teacher surveys and/or interviews will solely be used by CONCORDIA for further processing, use, modifications, storage, publications, and analyzations resulting in certain outputs and results with regard to the related CONCORDIA project. CONCORDIA will not use the surveys and interviews to collect special Personal Data such as information regarding political views, race, religious beliefs, health, criminal-law data, or other matters.

Any Personal Data will be processed in a proper, careful and safe manner by taking technical and organizational measures according to the GDPR, and in accordance with the applicable laws. All Personal Data collected during the Teach-the-Teacher surveys and/or interviews shall remain within the European Union and will be retained for as long as the CONCORDIA project runs. Personal Data will be shared with the CONCORDIA consortium partners in order to perform and execute their project under the grant agreement. Further, CONCORDIA is obliged to share and disclose Personal Data with the European Commission in order to comply with the grant agreement and audit obligations thereto.

This Statement is governed by EU law and supplemented by the laws of Belgium if necessary. Any and all disputes that may arise with respect to this Statement will be referred exclusively to the competent court in Brussels, Belgium. In addition, a Participant has the right to file a compliant at the national Data Protection Authority.
