




It's been more than two years since we have launched the CONCORDIA map displaying short courses and trainings for cybersecurity professionals. The map is complementing the ENISA database of university related programs, and aims at showcasing in a structured way relevant content from all over Europe, thus contributing to building a European Education Ecosystem for Cybersecurity. The CONCORDIA courses map was revamped and includes new features for the benefit of both the end users such as corporates, SME/startups, specialized organizations, individuals, and the course providers.

A LORIA's research team has been rewarded in a "bug bounty" program launched by Swiss Post for the scrutiny of its electronic voting protocol.

Véronique Cortier (Research director - CNRS), Alexandre Debant (post-doctoral researcher, INRIA), and Pierrick Gaudry (research director - CNRS) were rewarded with a €40,000 "bug bounty". This "bug bounty" program was organized by Swiss Post, in order to scrutinize and strengthen the security of its electronic voting system. The institution published the code on the European collaborative cybersecurity platform YesWeHack. The flaw discovered by the three researchers will allow the company to correct its protocol and better protect the secrecy of the vote. The team of researchers is delighted with this result and salutes the transparency approach led by the Swiss institution.

State of the Union: Commission proposes a Path to the Digital Decade to deliver the EU's digital transformation by 2030

The European Commission proposed a Path to the Digital Decade, a concrete plan to achieve the digital transformation of our society and economy by 2030. The proposed Path to the Digital Decade will translate the EU's digital ambitions for 2030 into a concrete delivery mechanism. It will set up a governance framework based on an annual cooperation mechanism with Member States to reach the 2030 Digital Decade targets at Union level in the areas of digital skills, digital infrastructures, digitalisation of businesses and public services. It also aims to identify and implement large-scale digital projects involving the Commission and the Member States.

On the 15-16 June, ECSO held its 9th Cyber Investor Days, organised together with the National Cybersecurity Centre of Portugal (CNCS), ScaleUp Porto, S21Sec, Bright Pixel, and Maxive as part of the C-DAYS Annual Cybersecurity Conference in Porto. One of the news that announced was that the Basque Region, with support from ECSO and the EIB Advisory Hub, would be conducting a feasibility study for the design of a European Cybersecurity Investment Platform.

The Entrepreneurship Explorer Ruhr 2021 offered international and entrepreneurialminded early career researchers in cyber security the possibility to implement their innovative business ideas and explore the regional start-up ecosystem of one of the most active start-up communities in cyber security. Apart from leading companies in data security, international renowned research institutes and a specialized VC fund, field-specific incubator Cube 5 [https://cube-five.de/en/] is part of this vibrant ecosystem. the eurobits start-up pitch is part of the European Cybersecurity STARtup Award by the European Cybersecurity Organisation (ECSO)



EIT digital announced names of 20 deep tech scaleups to compete in the EIT DigitalChallenge Final 2021. On September 21, European investors, corporates, and innovation stakeholders, will select the 3 winners that will receive prizes totalling €250,000. One of the finalists is CYSEC data security company with headquarters at the EPFL Innovation Park in Switzerland and one of the new members of PECS-UP community. CYSEC ARCA Trusted OS offers a hardware-based Trusted Execution Environment (TEE) to protect highly sensitive data, code and intellectual property.

ECSO's STARtup Award was initiated in 2020 to accelerate cybersecurity investment activities in Europe and recognise the next European champions in cybersecurity. The Germany-based PHYSEC (check interview with the founder in the previous PECS-UP CONCORDIA newsletter) became the first European cybersecurity company receiving the ECSO's STARtup Award. Now, ECSO has launched the 2nd edition of the Award. Finalists will come from series of local competitions, namely eurobits start-up pitch (WEBSITE: https://www.eurobits.de/eurobitssecurity-summit-2021/application-startup-pitch/), ECW Investor Day (WEBSITE: https://www.european-cyberweek.eu/investor-day), ECSO's Cyber Investor Days (WEBSITE: https://ecsorg.eu/newsroom/10th-cyber-investordays) and Cyber Wales Investor Day (WEBSITE:

https://cyberwales.net/competitions/).
Up to 2 companies from each event will be nominated for the ECSO's STARtup Award final competition, which will take place as an in-person event in the Hague, in February 2022.
